The Board of Aldermen of the City of Golden City, Missouri met in regular session at 6:00 p.m. on May 3, 2021, at 701 Depot Avenue. Mayor Pro Tem Linda Welch presided, and the following members of the Board of Aldermen answered the roll call: Sharon Wingert, Carla Davis, Vicky Jones, Sara Beerly and Chris Peterson. Other city officials present were City Clerk Breeyn Pettengill, Fire Chief Eric White, and Public Works Director Allen Singer.

**MINUTES:** *Beerly moved, seconded by Wingert, the minutes of the Regular Session of April 1, 2019, be approved as presented. All in favor.*

**UNFINISHED BUSINESS.** Mr. Rogers, City Building Inspector, submitted a report on the progress of the condemnations in town. Discussion was held on the status of the ones set for demolition.

The Ways and Means committee informed the board that they received three applications for the seasonal help and one did not show up for the interview. The remaining two interviewed well and at this time ***Beerly motioned seconded by Jones to hire Brenton Bilyeu for the seasonal part time position. All in favor. Motion carried.***

Mayor Pro Tem Welch informed the board that since only the incumbents signed up for the office of Aldermen there was no need for an election. She thanked them for staying with us.

**BILLS:** Following a review of the bills presented by the City Clerk, ***Beerly motioned, seconded by Wingert, to pay the bills presented by the City Clerk. All in favor. Motion carried.***

**OATHS ADMINISTERED:** The oath of office was administered by the City Clerk to Vicky Jones, Carla Davis, and Sharon Wingert as newly elected Aldermen.

Mayor Pro Tem Welch asked for a roll call. The following members of the Board of Aldermen answered the roll call: Vicky Jones, Chris Peterson, Sharon Wingert, Linda Welch, Carla Davis, and Sara Beerly present.

**PUBLIC PARTICIPATION, VISITORS:** Wayne Yardley approached the board concerning Ordinance Number 833. He stated that he would like the Ordinance be tabled for further review. Discussion was held.

**SHERIFF'S REPORT:** No report was submitted. No officer was present.

**FIRE DEPARTMENT:** Fire Chief Eric White had submitted a written report prior to the meeting.

**PUBLIC WORKS DEPARTMENT:** Public Works Director Allen Singer, submitted prior to the meeting.

**NEW BUSINESS:** Mayor Pro Tem Welch presented the renewal liquor applications for Casey's Marketing Company.

Applications for the renewal of the annual liquor licenses were reviewed from Casey's Marketing Company. ***Beerly moved, seconded by Wingert to approve the application for Casey's Marketing Company's regular package liquor license. Beerly, Peterson, Wingert, Jones, Davis Aye, Welch, Nay, motion carried.***

***Wingert moved, seconded by Beerly to approve the application for Casey's Marketing Company's Sunday package liquor license and issue the licenses pursuant thereto. Wingert, Beerly, Davis,***

***Peterson, Jones, Aye, Welch, Nay, motion carried.***

Mayor Pro Tem Welch presented the passing of the Annual Codes - Ordinance Number 833  
AN ORDINANCE ADOPTING AND ENACTING A NEW CODE OF ORDINANCES OF THE CITY OF GOLDEN CITY, COUNTY OF BARTON, STATE OF MISSOURI; ESTABLISHING THE SAME; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THERIN, EXCEPT AS HEREIN EXPRESSLY PROVIDED; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE OF ORDINANCES; PROVIDING PENALTY FOR THE VIOLATION THEREOF; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE

Discussion was held. ***Jones motioned; Davis seconded to suspend the ordinance until next board meeting for further examination. Jones, Davis, Beerly, Wingert, Welch, Aye. Peterson nay. Motion carried.***

***Beerly motioned, seconded by Jones, to suspend approval of authorized signers until next board meeting since Mayor Higgins was not present. All in favor motion carried.***

**MISCELLANEOUS HEARINGS:** Davis informed the board that with all the work that needs to be kept up at the park she would like to see a few tools and hose to be purchased. ***Beerly moved and Jones seconded that the necessary supplies be purchased and kept at the park. All in favor.***

Mayor Pro Tem Welch read a note that was mailed to the city from Larry Parrill thanking them for the 20-foot section of land approved at a previous meeting.

***Beerly motioned, seconded by Jones, the meeting be adjourned. All in favor, motion carried. (18:39)***
