The Board of Aldermen of the City of Golden City, Missouri met in regular session at 6:00 p.m. on September 07, 2021, at 701 Depot Ave. Mayor Higgins presided, and the following members of the Board of Aldermen answered the roll call: Linda Welch, Sharon Wingert, Vicky Jones, and Carla Davis, Sara Beerly was absent. Other city officials present were City Clerk Breeyn Pettengill, Public Works Director Allen Singer, and Fire Chief Eric White.

**MINUTES:** *Jones moved, seconded by Davis, the minutes of the Regular Session of August 2, 2021, be approved as presented. All in favor, Beerly absent. Motion carried.*

*Davis moved, seconded by Jones, to approve the special meeting minutes of August 23, 2021 as presented. All in favor, Beerly absent. Motion carried.*

**PUBLIC PARTICIPATION, VISITORS:** Dixie Taylor expressed concern about the lack of cooperation from the sheriffs department.

**SHERIFF'S REPORT:** No report was submitted. No officer was present.

**FIRE DEPARTMENT:** Fire Chief Eric White had submitted a written report prior to the meeting. The fire department will be hosting a biscuit and gravy cook off on October 2.

**PUBLIC WORKS DEPARTMENT:** Public Works Director Allen Singer, submitted prior to the meeting.

**Unfinished Business:** Mayor Higgins presented the board with Chris Petersons resignation from the board stating that due to several other obligations and endeavors it was in his best interest to resign.

**NEW BUSINESS:** Welch gave a report for the ways and means committee pertaining to the budget, Discussion was held. Mayor Higgins presented Council Bill Number 06-2021 Ordinance Number 837 "AN ORDINANCE SETTING THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING SEPTEMBER 1, 2021, AND ENDING AUGUST 31, 2022, AND APPROPRIATING FUNDS PURSUANT THERETO."

Said ordinance being furnished to all Alderpersons and posted for public inspection prior to the meeting was read by title only for the first reading. ***Davis moved, seconded by Wingert, to accept the first reading of the proposed ordinance by title only. Vote: Welch, Jones, Wingert, Davis Aye, Beerly absent, motion carried.***

Said ordinance being furnished for all Alderpersons and posted for public inspection prior to the meeting was read by title only for the second and final reading. ***Welch moved, seconded by Wingert, to accept the second and final reading of the proposed ordinance by title only. Vote: Welch, Jones, Wingert, Davis, Aye, Beerly absent, motion carried.***

Mayor Higgins declared that Council Bill Number 06-2021, Ordinance Number 837 is duly adopted this seventh (7<sup>th</sup>) day of September 2021. Council Bill Number 06-2021, Ordinance Number 837 was signed and sealed.

***Jones motioned, second by Davis to pay bills. All in favor, Beerly absent, Motion carried.***

***Welch motioned, seconded by Jones, the meeting be adjourned. All in favor, Beerly absent, motion carried. (19:30)***
