Ordinance 883 was discussed

Ordinance 883 An ordinance adopting and enacting a new Code of Ordinances of the City OF Golden City, COUNTY OF Barton, state OF Missouri; establishing the same; providing for the repeal of certain ordinances not included therein, except as herein expressly provided; providing for the manner of amending such Code of Ordinances; providing penalty for the violation thereof; and providing when this ordinance shall become effective. This ordinance was discussed and a vote was taken by title only.

The amended budget was discussed.

Carla Davis motioned Cassandra Probert second the motion to approve the amended budget. All in favor Motion carried.

The CDs that are set to mature were discussed. It was decided the 2 at Lamar Bank and Trust will continue and roll over into another 5-month CD. The one at Community National Bank will be placed in a 9-month CD.

The possible placement of speed bumps in the Parkview Drive loop was discussed, It was determined that if speed bumps were to be placed it would be at the expense of the residents, and the City was not responsible for maintenance.

The need for a battery powered grease gun for the City shop was discussed and approved by the council.

The request to purchase a new hose for the Jetter was discussed.

Carla Davis motioned Cassandra Probert second the motion to approve the purchase of a Jetter hose with it being paid for out of the Capital Improvement Fund. All in favor Motion carried.

Repairs and new equipment needed for the wastewater plant were discussed.

Carla Davis motioned Cassandra Probert second the motion to purchase 2 new small pumps for the Old Clarifier, a check valve for the Old Clarifier, and a check valve for the holding tank, with cost being split between the Equipment replacement fund and the Capitol Improvement Fund. All in favor Motion Carried.

MISCELLANEOUS HEARING

A discussion was held about the City lawn mowers and the possibility of replacing one of them this season.

The council discussed dissolving the contract with Richard "Bud" Rogers.

Rodney Evans motioned Carla Davis second the motion to dissolve the contract with Richard "Bud" Rogers effective immediately. All in favor Motion carried.

Cassandra Probert motioned Carla Davis second the motion to pay the bills. All in favor Motion carried.
