## **DEPARTMENT REPORTS**

Sheriff John Simpson was here to address the board with reports from his department. He stated that 234 calls from within the City limits have been answered since January 1<sup>st</sup>, 2025. This comes out to be around 11% of the total calls to the Sheriffs department. Some discussion was held concerning contracting an officer for Golden City and what the expenses would be.

Bud Rogers addressed the board with a building code that would benefit the City. There was a discussion of current codes that are in place, and what would need to be addressed prior to adopting a new building code. The board has asked for additional information to help revise the offered building code to fit the needs of Golden City.

Eric White addressed the board with the fire report. He also updated the board of upcoming events that the Fire Department will be participating in.

The Public Works report was discussed. There was a discussion concerning repairs that need to be done to a few pieces of equipment . All of this is very minor repairs due to basic wear and tear.
