The Board of Aldermen of the City of Golden City, Missouri met in regular session at 6:00 p.m. on July 5, 2022, at 701 Depot Avenue. Mayor Higgins presided, and the following members of the Board of Aldermen answered the roll call: Sharon Wingert, Vicky Jones, Joe Brewer, Danny Dillon Carla Davis, & Sara Beerly. Other city officials present were City Clerk Breeyn Pettengill, Fire Chief Eric White and Public works director Allen Singer.

MINUTES Beerly moved, seconded by Jones, the minutes of the Regular Session of July 18, 2022, be approved as presented. All in favor; motion carried.

PUBLIC PARTICIPATION, VISITORS: Elizabeth Hand approached the board with Financials from the community center. Discussion was held. Mayor Higgins informed Ms. Hand that the city is ready to acquire the building if the center so chooses. Ms. Hand replied by stating that she would meet with the Center board, they would vote on it, and get back with the city.

DEPARTMENTAL REPORTS:

SHERIFF'S REPORT: No report submitted

FIRE DEPARTMENT: Chief White submitted a report prior to the meeting. The Chief informed the board that they had purchased a poly tank for Brush One out of their donation checkbook.

PUBLIC WORKS DEPARTMENT: A report was submitted prior to the board meeting.

BUILDING INSPECTORS REPORT: No report was submitted. The clerk presented the letter that would be going out to all residents who are residing without city utilities. The board said it looked good.

NEW BUSINESS: Mayor Higgins informed the board we needed to create a committee for event centers if we move forward and he would like to see it comprised of both board members and community members. Wingert and Higgins both volunteered to be on the committee. City clerk presented the board with bids from Lakeland. Discussion was held ***Beerly motions to sign a lease with Lakeland at \$129 a month for an updated copier. Dillon seconds All in favor, motion carried.***

UNFINISHED BUSINESS. Brewer asked for the clerk to make a sample ordinance on Business License for the board to review.

MISCELLANEOUS: Mayor Higgins informed the board that a Representative from Vicky Hartzler's office visited the city last week and took a short tour of the town. Discussion was held on broadband.
