Ordinance 880 and 881 were discussed briefly.

Ordinance 880 An ordinance granting The Empire District Electric Company, a corporation, its successors and assigns, the right to use the streets, alleys and public grounds for the purpose of erecting and maintaining an electric distribution system, with the necessary poles, wires and other apparatus, equipment and appliances therefor, and to string wires above ground or carry same thereunder; and the right to do all things necessary and proper for the purpose of generating or otherwise procuring electric energy, or any part thereof, and distributing same throughout the *CITY* of **GOLDEN CITY**, Missouri, and of supplying and selling electric energy for light, power, heat and any other purposes to the said *CITY* and the inhabitants thereof, and fixing the terms and conditions upon which such rights may be granted and exercised. It was discussed and a vote was taken by title only.

Ordinance 881 “**AN ORDINANCE** authorizing and providing a contract between the **City of GOLDEN CITY, Missouri** (hereinafter sometimes called the CITY) and The Empire District Electric Company (hereinafter sometimes called the COMPANY), its successors or assigns, for electric service and equipment to light the CITY's streets, alleys, and public ways, electric service for light and power for the CITY's parks, other properties and public places, for a term of years, and specifying the prices to be paid for such lighting and power service, and the terms and conditions of such contract; and in consideration of COMPANY's covenants and obligations contained herein and COMPANY's acceptance of the terms and conditions contained herein for the establishment, operation and maintenance of the Company's facilities within the CITY; except providing further that nothing herein shall prohibit the CITY from lawfully collecting and Occupation Tax, License Tax, motor vehicle license fees and any ad valorem tax on the COMPANY's real estate and personal property.” It was discussed and a vote was taken by title only.
