The discussion was reopened about the 615 Main Street property. The council questioned what was going to be done on it and in what timeframe. Mr. Sprankle replied he was going to continue working on getting the concrete pad poured and remove the broken-up concrete that was piled up currently. It was determined after continued conversation that a letter of breach of contract would be issued to Mr. Sprankle. A 1-year extension would be allowed to correct the breach of contract. The letter will stipulate that in the 1-year extension a business must be operational, or the property will revert back to the City. The 1-year extension was set to start on 9-8-2025.

A discussion was held about repairs needed for the Ford pick-up.

A discussion was held about putting a porta-potty in East Park for the winter months.

MISCELLANEOUS HEARING

A discussion was held about holding a City wide Fall yard sale on the weekend of October 3rd and 4th. The council decided to advertise thru the Barton County Chamber of Commerce and on the water bills.

A discussion was held concerning signage for the City brush pile. The council has approved to put up signs per Public work request.

A discussion was held concerning the possibility of establishing zoning for certain areas of town creating commercial and industrial areas.
